






<u>Objective</u>: The results of the GS1 Sunrise 2027 Quickie Survey reveal limited engagement and low overall awareness, as evidenced by the very small response pool of just 14 companies across multiple revenue segments. Despite this low participation, the findings suggest that most respondents are not yet creating or modifying products or services to support the industry-wide transition to Sunrise 2027, with many indicating "neither" or expressing uncertainty about needed changes. This lack of preparation highlights a broader industry gap in understanding the operational and compliance impacts of GS1 Sunrise 2027. As adoption accelerates, this initiative will require packaging and processing companies to update coding practices, enhance product traceability, and align with evolving retailer and regulatory expectations, making awareness and readiness critical for maintaining competitiveness and ensuring seamless supply chain interoperability.




